Following the failed referendum on May 25, 2022, the Board of Finance mandated a reduction to the Board of Education's budget in the amount of \$200,000.

Mr. Moccio reviewed his proposed budget adjustments, and responded to questions from the Board members.

Mrs. Davis made a motion, seconded by Ms. Lybarger, that the Board of Education reduce the budget that was approved on Monday, April 25, 2022, by \$200,000.00, to meet the Board of Finance's mandate. Ms. Bushior, Mrs. Davis, Mr. Delano, Mr. Hoffman, Ms. Lybarger, and Ms. Kelley voted for the motion, which carried.

B. Review and Possible Approval of the SPS 2022-2025 District Technology Action Plan

Mr. Moccio introduced Mr. Steven Autieri, Director of Curriculum and Instruction, Ms. Erickson, District Technology Integration Specialist, and Mr. Dean Fortin, Director of Information Technology. They provided a brief summary of the changes made to the district's new three (3) year technology action plan.

Ms. Lybarger made a motion, seconded by Ms. Kelley, that the Board approve the Stafford Public Schools 2022 – 2025 District Technology Action Plan. Ms. Bushior, Mrs. Davis, Mr. Delano, Mr. Hoffman, Ms. Lybarger, and Ms. Kelley voted for the motion, which carried.

SUBJECT: Obsolete Equipment – Stafford Middle School School

Attached, please find a memorandum from Mr. Jonathan Campbell, Assistant Principal of Stafford Middle School, which details a list of library materials the school is requesting be declared as obsolete. Ms. Kate Levesque, Library Media Specialist, has completed an extensive weeding of materials in accordance with Section VII of BOE Policy #6163.1 – Material Selection Policy for School Libraries. The weeded materials were first offered to staff for classroom collections before being listed as obsolete.

Per Board of Education policy 3260-*Sales and Disposal of Books, Equipment, and Supplies*, such obsolete equipment must be returned to the Town of Stafford prior to disposal. Should the Board of Education approve labeling the materials obsolete, the district will first offer them to the town. Should the town decline the materials, the district will assume responsibility for proper disposal.

RECOMMEND the Board of Education approve the return of the obsolete materials, as detailed on the attached memorandums, to the Town of Stafford, in accordance with the provisions of Board policy 3260-*Sales and Disposal of Books, Equipment, and Supplies*.

The Stafford Middle School Library has continued to evaluate the existing collection in order to provide the most current, up-to-date material for students. Weeding the collection is a key factor in increasing student engagement with the collection and providing information that is not out-dated or erroneous. It was realized in 2021 that the current average age of the SMS collection is 2002 - almost 20 years out of date. The LMS will continue to weed the collection extensively in an effort to provide the best materials for our students and staff. When weeding books the CREW method of maintaining the collection is used. This includes looking at the copyright date, condition of the book, the number of times it has circulated in the last seven years, and the relevance to the students' interests today. The selected books have never circulated in the past seven years and are out-dated titles, or are heavily damaged. You will notice there are books dating back to 1945. These books have been offered to classroom libraries.

Attached is a memorandum from Mrs. Diane Peters, Business Manager, that includes explanations of various budget lines. Included with that memorandum is a financial report, sorted by object code, detailing budgeted and encumbered/expended funds from July 1, 2021, through May 31, 2022. The report includes the projected remaining balances at the conclusion of the 2021-2022 fiscal year, which will be reviewed each month moving forward.

The total budget for the 2021-2022 school year is \$29,086,760.86. As indicated in the attached memorandum, the expenses year to date total \$24,090,619.25, or 82.82% of the total budget. The projected remaining balance is (\$272,780.39), largely due to increased special education costs and unanticipated repairs in the various schools. On June 7, 2022, Diane Peters and I attended the Board of Finance meeting and requested the Excess Cost grant money received by the town from the Connecticut State Department of Education for the 2021-2022 school year be transferred to the Board of Education budget to cover the additional expense. Following the transfer of Excess Cost grant money to the Board of Education, should the projections be accurate, the end of year balance would be \$16,329.16. I plan to request the Board of Finance shift any remaining balance into the non-lapsing unexpended fund at the completion of the yearly audit to assist the district with completion of items on the Capital Improvement Plan, which was previously presented.

Mrs. Peters will be in attendance at the meeting on June 20, 2022, to provide more specific information regarding object codes and her projections, as well as respond to questions from the Board.

The year-to-date expenditure report for the period of July 1 and May 31, 2022 is attached. Projected remaining balances are included; these projections are based on current activity and historical spending.

The salaries line, 100, is encumbered for filled positions and shows a current remaining amount of \$339,175.66. Remaining expenditures are projected to reduce this amount to a \$333,982.58 after payment for substitutes, stipends, and other amounts owed.

The remaining balance in the benefits line, 200, is \$230,610.65. Any amount remaining in the employee benefits line, 210, will be deposited into the health reserve and is not included in the projected remaining balance of \$37,983.74.

Professional services, line 300, are payments for services for student related services to comply with mandates, professional development, legal fees, consultants and the security officer. The remaining balance at this time is \$(185,979.64). The projected remaining balance is \$(23,143.84) after the Medicaid reimbursement is netted with the services line and after purchase orders with remaining unused balances are closed.

Repairs, rental and other property services has a remaining balance of \$(92,630.01). The projected remaining balance is \$(66,354.23) after receipt from the town of amounts paid by the district for the middle school roof project.

Transportation, tuition and other services have a remaining balance of \$(611,994.61) with a projected remaining balance of \$(233,834.01) after the excess cost reimbursement is factored in.

The remaining balance in the 600 line of the budget is \$41,524.04. The cost of supplies, like paper, have increased this year and are expected to continue rising. The projected remaining balance in the 600 line is \$3,196.00. Oil prices play a large part in this low

remaining balance, once we used all of the oil that was contracted for, we paid current prices which are much higher.

Line 700, equipment and software expenditures has a remaining balance at this time of (\$627.49) with a projected remaining amount of \$22,744.92. The district was awarded funding from the Emergency Connectivity Fund and once that money is received the remaining balance will increase.

The 800 line of the budget covers various membership dues, licensing fees and a debt service line for the solar project lease payment. Overall, the line has a remaining balance of \$7,141.01 with a projected remaining balance of \$41,754.00 after reducing the amount of debt service owed to the town for energy usage.

The unspent, unreserved amount of the 2021-22 budget is \$(272,780.39). Year to date expenses represent 82.82% of the total budget. The projected remaining balance for the 2021-22 budget is \$16,329.16 after Excess Cost and Medicaid have been applied to the balance and remaining expenses have been paid.






A memo has been included from Mr. Marco Pelliccia, Principal of Stafford High School, on behalf of Ms. Caren Falzarano, Stafford High School English Teacher, and Mrs. Rosalba Onofrio, Stafford High School World Language Teacher, for a trip to Italy in the spring of 2023. As you are aware, the new Italian course has been met with much success and an additional Italian II course is being offered for the 2022-2023 school year. International trips are valuable opportunities for “hands on” experiential learning, while allowing students to immerse themselves in another culture. A detailed 9-day, 8-night itinerary, along with accompanying information and required forms have also been provided for your review.

According to the attached documents, the trip will be organized through Explorica and each participant will assume the cost of his/her own travel, which is estimated to be \$3,731. The trip is planned for April 6, 2023, through April 14, 2023, which is during Spring Vacation, meaning students and teachers will not be missing any instructional days. The documentation also indicates that there will be one adult chaperone per five students, meeting the requirements of Board of Education Policy 6153, Field Trips / Foreign Trips, and its accompanying regulation.

While current Board policy requires the recommendation and approval of foreign trips from the Superintendent, I would like the Board to be involved in this process due to heightened security considerations and implemented health measures internationally.



My child _____ has my permission to participate in the Italy trip expected to take place on or about April 6-14, 2023. This trip is school-sponsored and will be conducted under the supervision of Caren Falzarano and Rosalba Onofrio. I understand that the trip will involve touring France and Spain. My child and I understand that during the Stafford High School travel experience, my child will be representing the Stafford Public Schools, the State of Connecticut, and the United States of America.

My child and I understand and agree to the following guidelines governing student conduct during the trip:

1. Students acknowledge that their behavior while abroad will reflect on themselves, their families, their teachers, their school, and their country, and they will thus conduct themselves appropriately and in a manner that is expected of every Stafford public school student at all times in accordance with this Student Conduct Agreement.
2. Students will at all times follow local law, all rules and instructions given by chaperones, the rules and school handbook of their school, and all Stafford Board of Education Policies and regulations.
3. Students will at all times be respectful to tour guides, tour managers, bus drivers, chaperones and all other individuals with whom the student comes into contact. Additionally, students will at all times be courteous in hotels and on all methods of transportation.
4. Students will observe all arranged meeting times and curfews established by the rules of the trip and the chaperones. Students will at all times remain with a peer during free times and, after curfew, will not leave his/her own room. Students will at no time leave the hotel individually or in groups after the group has checked in for the night, unless accompanied by a chaperone.
5. During sightseeing portions of the trip, the group will generally stay together. From time to time, the chaperones might agree to split into smaller supervised groups for certain defined periods of time, but at no time will any student be permitted to set off on his/her own.
6. Students will assume responsibility for their own belongings and will take special precautions to protect money, ATM/cash cards, passports, and train and airplane tickets.
7. Students will at no time operate a motor or motorized vehicle or purchase, possess, distribute, or use tobacco products or illegal drugs regardless of the legality of such purchase, possession, distribution, or use under local law.
8. Students will not purchase, possess, distribute, or consume drugs or alcoholic beverages, regardless of the legality of such purchase, possession, distribution, or consumption, or use under local law.

1. At the first sign of illness or injury, my child will immediately alert one of the chaperones in person or by telephone of his/her medical or health status.
2. The chaperones will then promptly make arrangements for my child to receive medical care, which may be from a local doctor, dentist or other healthcare professional, or, in the case of an emergency, a hospital or urgent care center.
3. I further understand that the expense of any medical visit will be borne by me. If a chaperone pays for such medical care, I understand that I am responsible for promptly reimbursing such chaperone.
4. As soon as possible, I understand that the chaperones will attempt to contact me in order to discuss my child's illness and in order to consult me regarding medical decision-making. However, I understand that it may not always be possible to reach me or one of the emergency contacts listed above in a timely manner. In such cases, I authorize the chaperones to make medical and health decisions for my child in the best interest of my child. Such medical and health decisions include whether to hospitalize, secure proper treatment for, and authorize injection, anesthesia, or surgery for my child.

I have read and I understand the above Medical and Illness Protocols for the trip and I have discussed these Protocols in depth with my child so that my child fully understands such Protocols. I agree to and authorize the use of such Medical and Illness Protocols for my child during his/her participation on the trip.

I further agree that I have read and understand, by going to their respective websites, any travel warnings from the U.S. Department of State or from the United States Centers for Disease Control regarding travel to France and Spain.

Acknowledgment and Assumption of Risks

Participant and Parent have discussed the activities and risks, and the Participant chooses to participate nevertheless.

Agreements of Release

The Participant or Parent, and his/her heirs, executors, administrators, representatives and assigns, hereby release and discharge the Stafford Board of Education (the "Board"), its officers, trustees, faculty, employees, agents and representatives, (individually and collectively referred to as "Released Parties") from, and agree not to sue any Released Party for, any and all claims that may arise from the travel program, any accident, illness or injury arising from the travel program, any liability, and any damage or injury caused by the Participant's negligence or willful acts or any other participant's acts or omissions during participation in a travel program, except to the extent caused by the gross negligence or willful misconduct of the Released Party.


Additional Provisions

Participant or Parent have read and understand, in addition to this Agreement, general trip information, Student Conduct Agreement, and Medical and Illness Protocols.

Participant or Parent represents that medical professionals have verified that Participant has no past or current physical or psychological condition that might adversely affect his or her participation in these activities, other than as described on the Medical Information and Protocols Form. Participant is fully capable of participating in this activity, with or without reasonable accommodations, without causing harm to himself/herself or others.

The Board's staff members may obtain or provide emergency hospitalization, surgical or other medical care for the Participant. In case of emergency, Participant or Parent understands that efforts will be made to secure proper treatment; and the Board, through its trip leaders, is authorized to administer aid and engage the services of a physician, dentist, or hospital if they deem it reasonable and necessary. In the case of medical emergency, the physician selected may hospitalize, secure proper treatment for, and order injection, anesthesia, or surgery for the Participant. The Board and any third-party medical care provider are authorized to exchange pertinent medical information. Efforts will be made to contact Parent and Emergency Contact in the event of medical emergency or serious illness involving the Participant, and to secure such person's consent prior to treatment. 

- h. Inclement Weather that causes complete cessation of services for at least 12 consecutive hours of the Common Carrier on which You are scheduled to travel;
- i. mechanical breakdown that causes complete cessation of services for at least 12 consecutive hours of the Common Carrier on which You are scheduled to travel;
- j. a government-mandated shutdown of an airport or air traffic control system for reasons other than terrorism or an act of war;
- k. You or Your Traveling Companion is in the military and called to emergency duty for a national disaster other than war;
- l. involuntary employer termination or layoff affecting You or a Traveling Companion. Employment must have been with the same employer for at least 1 continuous year;
- m. a Terrorist Incident that occurs within 30 days of Your Scheduled Departure Date in a city listed on the itinerary of Your Trip. Benefits are not provided if the Travel Supplier offers a substitute itinerary;
- n. revocation of Your previously granted military leave or re-assignment due to war. Official written revocation/re-assignment by a supervisor or commanding officer of the appropriate branch of service will be required.

Additional Trip Interruption Benefits:

If Your Traveling Companion must remain hospitalized, benefits will also be paid for reasonable accommodation and local transportation expenses incurred by You to remain with Your Traveling Companion up to \$100 per day, limited to 5 days.

If You cannot continue travel due to a covered Injury or Sickness not requiring hospitalization and You must extend Your Trip due to medically imposed restrictions, as certified by a Legally Qualified Physician, benefits will be paid for additional hotel nights, meal(s) and local transportation expenses up to \$100 per day, limited to 5 days.

These benefits will not duplicate any other benefits payable under the Plan or any coverage(s) attached to the Plan.

MISSED CONNECTION

If You miss Your Trip departure because Your arrival at Your Trip destination is delayed for 3 or more hours, due to:

- a. any delay of a Common Carrier (the delay must be certified by the Common Carrier);

These benefits will not duplicate any other benefits payable under the Plan or any coverage(s) attached to the Plan.

24 HOUR ACCIDENTAL DEATH AND DISMEMBERMENT

We will pay the percentage of the Principal Sum shown in the Table of Losses below when You, as a result of an Injury occurring during Your Trip sustain a loss shown in the Table of Losses below. The loss must occur within one hundred eighty one (181) days after the date of the Injury causing the loss. The Principal Sum is the Maximum Benefit Amount shown in the Schedule of Benefits.

Loss of one hand	50% of Principal Sum
Loss of one foot	50% of Principal Sum
Loss of one eye	50% of Principal Sum

Loss of hand or hands, or foot or feet, means severance at or above the wrist joint or ankle joint, respectively.

Loss of eye or eyes means the total and irrecoverable loss of the entire sight thereof.

Only one of the amounts shown above (the largest applicable) will be paid for injuries resulting from one accident.

The benefit for loss of: (a) two limbs; (b) both eyes; or (c) one limb and one eye is payable only when such loss results from the same accident.

The Principal Sum is shown in the Schedule of Benefits.

These benefits will not duplicate any other benefits payable under the Plan or any coverage(s) attached to the Plan.

BAGGAGE AND PERSONAL EFFECTS

Benefits will be provided to You, up to the Maximum Benefit Amount shown in the Schedule of Benefits: (a) against all risks of permanent loss, theft or damage to Your Baggage and Personal Effects; (b) subject to all General Exclusions and the Additional Limitations and Exclusions Specific to Baggage and Personal Effects in the Plan; and (c) occurring while coverage is in effect.

Valuation and Payment of Loss: The lesser of the following amounts will be paid:

- 1) the Actual Cash Value at the time of loss, theft or damage, except as provided below;
- 2) the cost to repair or replace the article with material of a like kind and quality; or
- 3) \$300 per article.

For claimed items without original receipts, payment of loss will be calculated based upon 75% of the Actual Cash Value at the time of loss, not to exceed \$225 per article.

We may take all or part of a damaged Baggage as a condition for payment of loss. In the event of a loss to a pair or set of items, We will:

- 1) repair or replace any part to restore the pair or set to its value before the loss; or
- 2) pay the difference between the value of the property before and after the loss.

A combined maximum of \$600 will be paid for jewelry; precious or semi-precious stones; watches; articles consisting in whole or in part of silver, gold or platinum; furs or articles trimmed with fur; cameras and their accessories and related equipment.

A maximum of \$50 will be paid for the cost of replacing a passport or visa.

A maximum of \$50 will be paid for the cost associated with the unauthorized use or replacement of lost or stolen credit cards, subject to verification that You have complied with all conditions of the credit card company.

Baggage and Personal Effects does not include:

- 1) animals;
- 2) automobiles and automobile equipment;
- 3) boats or other vehicles or conveyances;
- 4) trailers;
- 5) motors;
- 6) aircraft;
- 7) bicycles, except when checked as baggage with a Common Carrier;
- 8) household effects and furnishings;
- 9) antiques and collectors items;
- 10) eyeglasses sunglasses, contact lenses, artificial teeth, dentures, dental bridges, retainers, or other orthodontic devices or hearing aids;
- 11) artificial limbs or other prosthetic devices;
- 12) keys, money, stamps and credit cards (except as otherwise specifically covered herein);
- 13) securities, stamps, tickets and documents (except as coverage is otherwise specifically provided herein);
- 14) professional or occupational equipment or property, whether or not electronic business equipment;
- 15) sporting equipment if the loss results from the use thereof; or
- 16) telephones or PDA devices, computer hardware or software.

BAGGAGE DELAY

We will reimburse You, up to the amount shown in the Schedule of Benefits, for the cost of reasonable additional clothing and personal articles purchased by You, if Your Baggage is delayed for 24 hours or more during Your Trip.

We will also reimburse You up to \$50 for expenses incurred during Your Trip to expedite the return of Your delayed Baggage. This coverage terminates upon Your arrival at the return destination of Your Trip.

Additional Limitations and Exclusions Specific to Baggage and Personal Effects:

Benefits are not payable for any loss caused by or resulting from:

- a) breakage of brittle or fragile articles;
- b) wear and tear or gradual deterioration;
- c) confiscation or appropriation by order of any government or custom's rule;
- d) theft or pilferage while left in any unlocked vehicle;
- e) property illegally acquired, kept, stored or transported;
- f) Your negligent acts or omissions;
- g) Your property shipped as freight or shipped prior to the Scheduled Departure Date;
- h) electrical current, including electric arcing that damages or destroys electrical devices or appliances.

Additional Provisions applicable to Baggage and Personal Effects and Baggage Delay:

Benefits will not be paid for any expenses which have been reimbursed or for any services which have been provided by the Common Carrier, hotel or Travel Supplier.

Additional Claims Provisions Specific to Baggage

Your Duties After Loss of or Damage to Property or Delay of Baggage:

In case of loss, theft, damage or delay of baggage or personal effects, and You must:

- a) take all reasonable steps to protect, save or recover the property;
- b) promptly notify, in writing, either the police, hotel proprietors, ship lines, airlines, railroad, bus, airport or other station authorities, tour operators or group leaders, or any Common Carrier or bailee who has custody of Your property at the time of loss;
- c) produce records needed to verify the claim and its amount, and permit copies to be made;

SECTION III. INSURING PROVISIONS

"Pre-Existing Condition" means an illness, disease, or other condition during the 60 day period immediately prior to the date Your coverage is effective for which You or Your Traveling Companion, Business Partner or Family Member scheduled or booked to travel with You: (1) received or received a recommendation for a test, examination, or medical treatment for a condition which first manifested itself, worsened or became acute or had symptoms which would have prompted a reasonable person to seek diagnosis, care or treatment; or (2) took or received a prescription for drugs or medicine.

Item #2 of this definition does not apply to a condition which is treated or controlled solely through the taking of prescription drugs or medicine and remains treated or controlled without any adjustment or change in the required prescription throughout the 60 day period before coverage is effective under this Plan.

"Prepaid" means Payments or Deposits paid by You for Travel Arrangements for Your Trip prior to Your actual or Scheduled Departure Date. Payments or Deposits for shore excursions, theater, concert or event tickets or fees, or sightseeing, if such arrangements are made during Your Trip and are to be used prior to the Scheduled Return Date of Your Trip, are not considered Prepaid as defined herein.

"Program Medical Advisor" means Generali Global Assistance.

"Scheduled Departure Date" means the date on which You are originally scheduled to leave on Your Trip.

"Scheduled Return Date" means the date on which You are originally scheduled to return to the point of origin or the original final destination of Your Trip.

"Sickness" means an illness or disease of the body which: 1) requires examination and treatment by a Legally Qualified Physician; and 2) commences while Your coverage is in effect.

"Strike" means any organized and legally sanctioned labor disagreement resulting in a stoppage of work: (a) as a result of a combined effort of workers which was unannounced and unpublished at the time travel services were purchased; and (b) which interferes with the normal departure and arrival of a Common Carrier.

"Terrorist Incident" means an act of violence, that is deemed terrorism by the United States Government other than civil disorder or riot (that is not an act of war, declared or undeclared) that results in loss of life or major damage to property, by any person acting alone or in association with other persons on behalf of or in connection with any organization of foreign government which is generally recognized as having the intent to overthrow or influence the control of any other foreign government.

"Third Party" means a person or entity other than You or Us.

"Transportation Expense" means the cost of Medically Necessary conveyance, personnel, and services or supplies.

"Travel Arrangements" means: (a) transportation; (b) accommodations; and (c) other specified services arranged by the Travel Supplier for Your Trip.

"Travel Supplier" means Explorica.

"Traveling Companion" means a person or persons whose names appear with Yours on the same Travel Arrangements and who, during Your Trip, will accompany You. A group or tour organizer, sponsor or leader is not a Traveling Companion as defined, unless sharing accommodations in the same room, cabin, condominium unit, apartment unit or other lodging with You.

"Trip" means a scheduled trip for which coverage for Travel Arrangements is requested and the premium is paid prior to Your actual or Scheduled Departure Date of Your Trip.

"Us", "We", "Our" means United States Fire Insurance Company.

"Usual and Customary Charges" means those comparable charges for similar treatment, services and supplies in the geographic area where treatment is performed.

Who Is Eligible For Coverage:

A citizen or resident of the United States of America who is booked to travel on Your Trip and for whom the required plan payment is paid.

When Coverage For Your Trip Begins – Coverage Effective Date:

Trip Cancellation: Coverage begins at 12:01 a.m. on the day after the date the appropriate payment for this Plan is received by Explorica; or 2) if mailed, at 12:01 a.m. on the day after the postmark date the appropriate payment for this Plan is received by Explorica. This is Your "Effective Date" and time for Trip Cancellation.

Travel Delay: Coverage begins after You have traveled 50 miles or more from home en route to join Your Trip. This is Your "Effective Date" and time for Travel Delay.

All Other Coverages: Coverage begins when You depart on the first Travel Arrangement (or alternate travel arrangement if You must use an alternate travel arrangement to reach Your Trip destination) for Your Trip. This is Your "Effective Date" and time for all other coverages, except Trip Cancellation and Travel Delay.

When Coverage For Your Trip Ends – Coverage Termination Date:

Trip Cancellation: Your coverage automatically ends on the earlier of: 1) the scheduled departure time on the Scheduled Departure Date of Your Trip; 2) the date and time You depart on Your Trip; or 3) the date and time You cancel Your Trip.

All Other Coverages: Your coverage automatically ends on the earlier of: 1) the date Your Trip is completed; 2) the Scheduled Return Date; 3) Your arrival at Your return destination on a round-trip, or the destination on a one-way trip; 4) cancellation of Your Trip covered by this Plan. Termination of this Plan will not affect a claim for loss that occurs after plan payment has been paid.

Extension of Coverage:

All coverages under this Plan will be extended if Your entire Trip is covered by this Plan and Your return is delayed due to unavoidable circumstances beyond Your control. This extension of coverage will end on the earlier of the date You reach Your originally scheduled return destination or 7 days after the Scheduled Return Date.

SECTION IV. GENERAL EXCLUSIONS

Benefits are not payable for any loss due to, arising or resulting from:

1. suicide, attempted suicide or any intentionally self-inflicted injury of You, a Traveling Companion, Family Member or Business Partner booked to travel with You, while sane or insane;
2. an act of declared or undeclared war;
3. participating in maneuvers or training exercises of an armed service, except while participating in weekend or summer training for the reserve forces of the United States, including the National Guard;
4. riding or driving in races, or speed or endurance competitions or events;
5. mountaineering (engaging in the sport of scaling mountains generally requiring the use of picks, ropes, or other special equipment);
6. participating as a professional in a stunt, athletic or sporting event or competition;
7. participating in skydiving or parachuting except parasailing, hang gliding, bungee cord jumping, extreme skiing, skiing outside marked trails or heli-skiing, any race, speed contests, spelunking or caving, or scuba diving if the depth exceeds 120 feet (40 meters) or if You are not certified to dive and a dive master is not present during the dive;
8. piloting or learning to pilot or acting as a member of the crew of any aircraft;
9. being intoxicated as defined herein, or under the influence of any controlled substance unless as administered or prescribed by a Legally Qualified Physician;

Reductions in the Amount of Insurance: The applicable benefit amount will be reduced by the amount of benefits, if any, previously paid for any loss or damage under this coverage for Your Trip.

SECTION VI. COORDINATION OF BENEFITS

Applicability

The Coordination of Benefits ("COB") provision applies to This Plan when an Insured has health care coverage under more than one Plan. "Plan" and "This Plan" are defined below.

If this COB provision applies, the order of benefit determination rules should be looked at first. Those rules determine whether the benefits of This Plan are determined before or after those of another Plan. The benefits of This Plan:

- (a) will not be reduced when, under the order of benefit determination rules, This Plan determines its benefits before another Plan; but
- (b) may be reduced when, under the order of benefit determination rules, another Plan determines its benefits first. This reduction is described further in the section entitled Effect on the Benefits of This Plan.

Definitions

"Plan" is a form of coverage written on an expense incurred basis that provides benefits or services for, or because of, medical or dental care or treatment. "Plan" includes:

- (a) group insurance and group remittance subscriber contracts;
- (b) uninsured arrangements of group coverage;
- (c) group coverage through HMO's and other prepayment, group practice and individual practice Plans; and
- (d) blanket contracts, except blanket school accident coverages or a similar group.

"Plan" does not include individual or family: (a) insurance contracts; (b) direct payment subscriber contracts; (c) coverage through HMO's; or (d) coverage under other prepayment, group practice and individual practice Plans.

"This Plan" is the parts of this blanket contract that provide benefits for health care expenses on an expense incurred basis.

"Primary Plan" is one whose benefits for a person's health care coverage must be determined without taking the existence of any other Plan into consideration. A Plan is a Primary Plan if either:

- (a) the Plan either has no order of benefit determination rules, or it has rules which differ from those in the contract; or
- (b) all Plans that cover the person use the same order of benefits determination rules as in this contract, and under those rules the Plan determines its benefits first.

"Secondary Plan" is one that is not a Primary Plan. If a person is covered by more than one Secondary Plan, the order of benefit determination rules of this contract decide the order in which their benefits are determined in relation to each other. The benefits of each Secondary Plan may take into consideration the benefits of the Primary Plan or Plans and the benefits of any other Plan, which, under the rules of this contract, has its benefits, determined before those of that Secondary Plan.

"Allowable Expense" is the necessary, reasonable, and customary item of expense for health care; when the item of expense is covered at least in part under any of the Plans involved.

The difference between the cost of a private hospital room and a semi-private hospital room is not considered an Allowable Expense under the above definition unless the patient's stay in a private hospital room is medically necessary in terms of generally accepted medical practice.

When a Plan provides benefits in the form of services, the reasonable cash value of each service will be considered both an Allowable Expense and a benefit paid.

"Claim" is a request that benefits of a Plan be provided or paid. The benefits claimed may be in the form of: (a) services (including supplies); (b) payment for all or a portion of the expenses incurred; or (c) a combination of (a) and (b).

"Claim Determination Period" is the period of time, which must not be less than 12 consecutive months, over which Allowable Expenses are compared with total benefits payable in the absence of COB, to determine: (a) whether overinsurance exists; and (b) how much each Plan will pay or provide.

For the purposes of this contract, Claim Determination Period is the period of time beginning with the Effective date of coverage and ending 12 consecutive months following the date of loss or longer as may be determined by the proof of loss provision.

Order of Benefit Determination Rules

When This Plan is a Primary Plan, its benefits are determined before those of any other Plan and without considering another Plan's benefits.

When This Plan is a Secondary Plan, its benefits are determined after those of any other Plan only when, under these rules, it is secondary to that other Plan.

When there is a basis for a Claim under This Plan and another Plan, This Plan is a Secondary Plan that has its benefits determined after those of the other Plan, unless:

- (a) the other Plan has rules coordinating its benefits with those of This Plan; and
- (b) both those rules and This Plan's rules, as described below, require that This Plan's benefits be determined before those of the other Plan.

Rules. This Plan determines its order of benefits using the first of the following rules which applies:

- (a) **Nondependent/Dependent Rule.** The benefits of the Plan which covers the person as an employee, member or subscriber (that is, other than as a dependent) are determined before those of the Plan that covers the person as a dependent.
- (b) **Longer/Shorter Length of Coverage Rule.** The benefits of the Plan that covered an employee, member or subscriber longer are determined before those of the Plan that covered that person for the shorter time.

To determine the length of time a person has been covered under a Plan, two Plans shall be treated as one if the claimant was eligible under the second within 24 hours after the first ended. Thus, the start of a new Plan does not include: (a) a change in the amount or scope of a Plan's benefits; (b) a change in the entity which pays, provides or administers the Plan's benefits; or (c) a change from one type of Plan to another. The claimant's length of time covered under a Plan is measured from the claimant's first date of coverage under that Plan. If that date is not readily available, the date the claimant first became a member of the group shall be used as the date from which to determine the length of time the claimant's coverage under the present Plan has been in force.

Effect on the Benefits of This Plan When it is Secondary

The benefits of This Plan will be reduced when it is a Secondary Plan so that the total benefits paid or provided by all Plans during a Claim Determination Period are not more than the total Allowable Expenses, not otherwise paid, which were incurred during the Claim Determination Period by the person for whom the Claim is made. As each Claim is submitted, This Plan determines its obligation to pay for Allowable Expenses based on all Claims that were submitted up to that point in time during the Claim Determination Period.

ILLINOIS AMENDATORY ENDORSEMENT

This Amendatory Endorsement is attached to and made a part of Policy Number T210-MP issued to the Group and Blanket Accident and Health Trust (the Policyholder).

This Amendatory Endorsement is attached to and made a part of the Certificate issued to the Insured. The provisions of this Amendatory Endorsement are effective on the Effective Date and will expire concurrently with the Policy/Certificate, unless otherwise terminated.

The Policy/Certificate are hereby amended for Illinois as follows:

- A. Item b. (i) under “Other Covered Reasons” in both **COVERAGE TRIP CANCELLATION** and **COVERAGE TRIP INTERRUPTION** appearing in **SECTION I. COVERAGES** is deleted and replaced as follows:
- (i) the building structure itself is unstable and there is a risk of collapse;
- B. Item 1. in the Injury definition in both **COVERAGE TRIP CANCELLATION AND INTERRUPTION DUE TO YOUR INABILITY TO DIVE** and **COVERAGE LOST DIVING DAYS** appearing in **SECTION I COVERAGES** is deleted and replaced as follows:
1. is direct and independent of disease or bodily infirmity;
- C. Item B. in the Exclusions in **COVERAGE TRIP CANCELLATION AND INTERRUPTION DUE TO YOUR INABILITY TO DIVE** is deleted and replaced as follows:
- B. We will not be liable for claims, under the Coverage Part B, directly arising from any hazardous pursuit or occupation or flying except while flying as a passenger in a fully-licensed multi-engine passenger-carrying aircraft.
- D. The last sentence in the definition of “Injury” or “Injuries” appearing in **SECTION II DEFINITIONS** is deleted and replaced as follows:
- The Injury must be the direct cause of loss and must be independent of disease or bodily infirmity and must not be caused by, or result from, Sickness.
- E. The definition of “Complications of Pregnancy” appearing in **SECTION II DEFINITIONS** is deleted and replaced as follows:
- “Complications of Pregnancy” means conditions (when the pregnancy is not terminated) whose diagnoses are distinct from pregnancy but are adversely affected by pregnancy or are caused by pregnancy. These conditions include acute nephritis, nephrosis, cardiac decompensation, hyperemesis gravidarum, preeclampsia, missed abortion and similar medical and surgical conditions of comparable severity. Complications of Pregnancy also include nonelective cesarean section, ectopic pregnancy which is terminated and spontaneous termination of pregnancy, which occurs during a period of gestation in which a viable birth is not possible.
- Complications of Pregnancy does not include false labor, occasional spotting, Physician-prescribed rest during the period of pregnancy, morning sickness and similar conditions associated with the management of a difficult pregnancy not constituting a nosologically distinct complication of pregnancy.
- F. Item 1) in the definition of “Pre-Existing Condition” appearing in **SECTION II DEFINITIONS** is deleted and replaced as follows:
- 1) received or received a recommendation for a test, examination, or medical treatment for a condition which manifested itself, worsened or became acute or had symptoms which would have prompted a reasonable person to seek diagnosis, care or treatment;
- G. Item 1) in the Pre-Existing Condition Exclusion appearing in **SECTION IV General Exclusions** is deleted and replaced as follows:
- 1) received or received a recommendation for a test, examination, or medical treatment for a condition which manifested itself, worsened or became acute or had symptoms which would have prompted a reasonable person to seek diagnosis, care or treatment;

Illinois Guaranty Notice

Title 50, Chapter I, Subchapter 11, Part 3401 of the Illinois Insurance Code requires all Group Life and Health insurers to provide a summary of the basic provisions of the Illinois Life and Health Insurance Guaranty Association Law.

Residents of Illinois who purchase health insurance, life insurance, and annuities should know that the insurance companies licensed in Illinois to write these types of insurance are members of the Illinois Life and Health Insurance Guaranty Association. The purpose of this Guaranty Association is to assure that policyholders will be protected, within limits, in the unlikely event that a member insurer becomes financially unable to meet its policy obligations. If this should happen, the Guaranty Association will assess its other member insurance companies for the money to pay the covered claims of policyholders that live in Illinois (and their payees, beneficiaries, and assignees) and, in some cases, to keep coverage in force. The valuable extra protection provided by these insurers through the Guaranty Association is not unlimited, however, as noted below.

ILLINOIS LIFE AND HEALTH INSURANCE GUARANTY ASSOCIATION DISCLAIMER

The Illinois Life and Health Insurance Guaranty Association provides coverage of claims under some types of policies if the insurer becomes impaired or insolvent. **COVERAGE MAY NOT BE AVAILABLE FOR YOUR POLICY.** Even if coverage is provided, there are substantial limitations and exclusions. Coverage is generally conditioned on continued residence in Illinois. Other conditions may also preclude coverage.

You should not rely on availability of coverage under the Life and Health Insurance Guaranty Association Law when selecting an insurer. Your insurer and agent are prohibited by law from using the existence of the Association or its coverage to sell you an insurance policy.

If a policy's or contract's interest or changes in value are credited less frequently than annually, then for purposes of determining the values that have been credited and are not subject to forfeiture under this Section, the interest or change in value determined by using the procedures defined in the policy or contract will be credited as if the contractual date of crediting interest or changing values was the date of the impairment or insolvency, whichever is earlier, and will not be subject to forfeiture; or
 - M) any stop loss insurance.
- 2) In addition, persons are not protected by the Guaranty Association if:
- A) the Illinois Director of Insurance determines that, in the case of an insurer which is not domiciled in Illinois, the insurer's home state provides substantially similar protection to Illinois residents which will be provided in a timely manner; or
 - B) their policy was issued by an organization which is not a member insurer of the Association was not licensed or did not have a certificate of authority to issue the policy or contract in this State.
- d) Limits on Amount of Coverage:
- 1) The Law also limits the amount the Illinois Life and Health Insurance Guaranty Association is obligated to pay. The Guaranty's Association's liability is limited to the lesser of either:
 - A) the contractual obligations for which the insurer is liable or for which the insurer would have been liable if it were not an impaired or insolvent insurer, or
 - B) with respect to any one life, regardless of the number of policies, contracts, or certificates:
 - i) in the case of life insurance, \$300,000 in death benefits but not more than \$100,000 in net cash surrender or withdrawal values;
 - ii) in the case of health insurance:
 - a) \$100,000 for coverages not defined as disability insurance or basic hospital, medical, and surgical insurance or major medical insurance or long-term care insurance, including any net cash surrender and net cash withdrawal values;
 - b) \$300,000 for disability insurance and \$300,000 for long-term care insurance as defined in Section 351 A-1 of this Code; and
 - c) \$500,000 for basic hospital medical and surgical insurance and major medical insurance;
 - iii) with respect to annuities 100,000 in the present value of annuity benefits, including net cash surrender or withdrawal values, and \$100,000 in the present value of annuity benefits for individuals participating in certain government retirement plans covered by an unallocated annuity contract. The limit for coverage of unallocated annuity contracts other than those issued to certain governmental retirement plans is \$5,000,000 in benefits per contract holder, regardless of the number of contracts.
- e) However, in no event is the Guaranty Association liable for more than (1) in aggregate of \$300,000 in benefits with respect to any one life except with respect to benefits for basic hospital, medical and surgical insurance and major medical insurance in which case the aggregate liability of the Association shall not exceed \$500,000 with respect to any one individual or (2) with respect to one owner of multiple nongroup policies of life insurance, whether the policy owner is an individual, firm, corporation, or other person and whether the persons insured are officers, managers, employees, or other persons, \$5,000,000 in benefits, regardless of the number of policies and contracts held by the owner.

Following our review of your Grievance, we must issue a written decision to you and, if applicable, to your representative or provider, within 20-days after receiving the Grievance. The written decision must include:

- (1) The name(s), title(s) and professional qualifications of any person(s) participating in the First Level Review process.
- (2) A statement of the reviewer's understanding of the Grievance.
- (3) The specific reason(s) for the reviewer's decision in clear terms and the contractual basis or medical rationale used as the basis for the decision in sufficient detail for the Insured to respond further to our position.
- (4) A reference to the evidence or documentation used as the basis for the decision.
- (5) If the claim denial is based on medical necessity, experimental treatment or similar exclusion, instructions for requesting an explanation of the scientific or clinical rationale used to make the determination.
- (6) A statement advising you of your right to request a Second Level Review, if applicable, and a description of the procedure and timeframes for requesting a Second Level Review.

Second Level Review

The Second Level Review process is available if you are not satisfied with the outcome of the First level Review for an Adverse Determination. Within ten business days after receiving a request for a Second Level Review, we will advise you of the following:

- (1) the name, address, and telephone number of a person designated to coordinate the Grievance review for the Company;
- (2) a statement of your rights, including the right to:
 - attend the Second Level Review
 - present his/her case to the review panel;
 - submit supporting materials before and at the review meeting;
 - ask questions of any member of the review panel;
 - be assisted or represented by a person of his/her choice, including a provider, family member, employer representative, or attorney.
 - request and receive from us free of charge, copies of all relevant documents, records and other information that is not confidential or privileged that were considered in making the Adverse Determination.

We must convene a review panel and hold a review meeting within 45-days after receiving a request for a Second Level Review. We will notify you in writing of the meeting date at least 15-days prior to the date. The review meeting will be held during regular business hours at a location reasonable accessible to you. In cases where a face-to-face meeting is not practical for geographic reasons, we will offer you the opportunity to communicate with the review panel at our expense by conference call or other appropriate technology. Your right to a full review may not be conditioned on whether or not you appear at the meeting.

If you choose to be represented by an attorney, we may also be represented by an attorney. If we choose to have an attorney present to represent our interests, we will notify you at least 15 working days in advance of the review that an attorney will be present and that you may wish to obtain legal representation of your own.

The panel must be comprised of persons who:

- (1) were not previously involved in any matter giving rise to the Second Level Review;
- (2) are not employees of the Company or Utilization Review Organization; and
- (3) do not have a financial interest in the outcome of the review.

A person previously involved in the Grievance may appear before the panel to present information or answer questions.

All persons reviewing a Second Level Grievance involving a Utilization Review non-certification or a clinical issue will be providers who have appropriate expertise, including at least one clinical peer. If we use a clinical peer on an appeal of a Utilization Review non-certification or on a First Level Review, we may use one of our employees on the Second Level Review panel if the panel is comprised of 3 or more persons.

We also limit employee access to personally identifiable information to those with a business reason for knowing such information. What kind of information do we collect about you and from whom?

We obtain most of our information from you. The application or claim form you complete, as well as any additional information you provide, generally gives us most of the information we need to know. Depending on the nature of your insurance transaction, we may need additional information about you or other individuals proposed for coverage. Personal Safety Tips

- ✓ **Situational Awareness**
 - Most incidents can be avoided by using common sense and making good choices.
 - Stay alert and focused on the instructions given by your Program Leader and Tour Director.
 - Always use a buddy system and never venture out alone, especially after dark.
 - Stick to highly populated areas; avoid neighborhoods that are off the beaten path.
 - Be cautious about using your smartphone while in public, especially on public transportation or while walking as this distracts you and may make you more vulnerable to accident or theft.
 - Be aware of your surroundings and suspicious activities, especially when using public transportation; use taxis from hotels or designated taxi stands only; when using rideshare apps, always make sure the car model and license plate match what is in the app.
 - If you see a suspicious package or are in a situation that makes you feel uncomfortable, trust your instincts, clear the area, and report the situation.

- ✓ **Avoiding Crime**
 - The most common crime in most destinations is petty theft—either pickpocketing or theft of unattended items.
 - Avoid wearing items that identify you as an obvious foreigner or otherwise call attention to your nationality, including clothing with logos.
 - Carry limited cash with you at any given time.
 - Stay alert at ATMs; to safeguard against fraud and theft, avoid using street locations and use only those located inside hotels, banks, airports, or other locations with additional security.
 - Leave valuable items at home.
 - If approached and told to hand over your valuables, do not resist. Everything can be replaced— except for you. Only resist if the perpetrator attempts to take *you*!
 - If you are a victim of crime, alert your Program Leader and Tour Director immediately.
 - In most cases, a report will need to be filed with police or tourist police, although for some crimes in some countries, Explorica may recommend that a police report not be filed.
 - When travelling by bus for airport or coach transfer, watch your luggage until it is loaded underneath the bus, whenever practical.
 - Note that mace/pepper spray, even small amounts for personal protection, are illegal in many countries.

- ✓ **Rallies, Protests, and Discord**
 - Avoid protests, rallies, and large gatherings, even if they seem calm, as they can turn angry or violent with little warning.
 - Do not attempt to observe and/or photograph demonstrations. Even if you are a bystander, police may consider you part of the protest if you are lingering to observe or take photos.
 - If locals try to start an argument with you or anyone in your group about politics, race, or religion, always disengage and walk away

- ✓ **Emergency Contacts**
 - Remember to store Explorica emergency contact numbers and the number of your Program Leader and Tour Director in your phone and learn the local equivalent of 911.

- ✓ At the Beach
 - Only swim when a lifeguard or chaperone is present.
 - Only swim in designated swimming areas.
 - Always practice the buddy system.
 - When traveling internationally, it is important to understand the beach rules and what different signs and flags mean in the destination so you can follow them.
 - Don't attempt to go swimming in poor weather conditions.
 - If unsure about the beach conditions, ask locals such as your hotel concierge about the area's swimming conditions.
 - Watch out for jellyfish and other sea creatures.
 - Don't forget to pack sunscreen and reapply often.
 - **Know how to identify and survive rip currents:**
 - Rip currents are powerful, narrow channels of fast-moving water that run away from the shoreline.
 - Rip currents are **dangerous**, even for very strong swimmers!
 - **If caught in a rip current, STAY CALM**
 - Motion for help immediately.
 - Swim parallel to shore to get out of the current.
 - Swim toward the shore once you escape the current.
 - **NEVER** attempt to enter the current yourself to save someone else. Instead **CALL FOR HELP IMMEDIATELY.**
- ✓ During Activities
 - Pay attention to the safety briefing and follow all the rules.
 - Make sure to wear any safety equipment provided, such as life jackets.
